



POWERFUL PAST FUTURE FOCUSED



When your Cooperative was founded in 1938, it was a grassroots movement to get affordable and reliable delivery of electricity to where others would not take the risk. So instead, leaders of this electric distribution cooperative movement took it upon themselves to band together and embark on what would be the best economic development tool in the history of rural America. Households and farms in the rural areas across America came to realize the benefits of the conveniences and efficiencies of the modern world.

Over the course of time, your Cooperative has been governed by community leaders that are also members of the Cooperative elected by their member peers. This model has proven to be one of the most effective governance structures available as it supports incredible organizational alignment. Decisions made locally are often very long term in nature, because the institutional investments required – the highly-skilled tradespeople, substations, poles, wire, transformers, line trucks, and generation equipment have useful lives that span decades of time. The organizational mission from day one – safe, reliable, and affordable power delivered to the rural areas – has resonated over the span of the rural cooperative movement's history.

It is the grassroots involvement of the member consumers that has led to the ultimate success of rural distribution cooperatives across the nation – over 900 of them exist today. With many upcoming challenges related to the changing landscape of the entire electric generation, transmission and distribution industry, the pace has been hastened when it comes to making those long-term decisions. They all have economic outcomes, but perhaps just as or more important, these decisions impact both near and distant-future resilience of the electric grid. The caveat - there are many opportunities to adapt to this unprecedented industry change as well.

Therefore, we would like to invite you to attend the 85th annual meeting of Shelby Electric Cooperative and plan for an enjoyable time visiting with friends, family, and neighbors over a fantastic meal. I also encourage you to stay for the business meeting that begins at 1pm to learn more about the current state of the industry and your Cooperative. We exist today for one reason – to serve you – the member.

PROPOSED CHANGE TO BYLAWS ARTICLE I

MEMBERSHIP

Section 2. Requirements for Membership for Class A Members and Section 3. Requirements for Membership for Class B Members

Any person or entity, including, but not limited to, a firm, association, corporation, partnership, limited liability company, trust, or body politic or subdivision thereof, will become a member of Shelby Electric Cooperative as a Class A member upon receipt of electric energy services from the Cooperative, provided that **they** or it has first:

(d) Agreed to provide the Cooperative, as required by the Cooperative for a "Cooperative Purpose," with (1) safe and reliable access to or use of Class A [or Class B for Section 3] member property, and (2) a grant and conveyance to the Cooperative, without charge or compensation from the Cooperative, of an easement, right-of-way, license, or other such right or interest over, through, under, and on property that is owned, occupied, or controlled by a Class A member. Said grant and conveyance of an easement or other rights shall be effective and enforceable even in the absence of a separate written easement or other agreement executed by the Class A [or Class B under Section 3] member. The member shall, nevertheless, sign a separate written easement or other agreement for recording purposes if requested to do so by the Cooperative.

For purposes of this Article I, Section 2 [or Section 3], a "Cooperative Purpose" shall include, but is not necessarily limited to the furnishing of electric energy or telecommunications services to either the Class A [or Class B for Section 3] member's land or to others, and the construction, extension, improvement, installation, operation, modification, maintenance, or relocation of the Cooperative's poles, lines, cables, fiber, and other materials and equipment necessary and incidental to the furnishing of electric energy and telecommunications services. A "Cooperative Purpose" may also include the cutting, trimming, or pruning of trees, shrubbery, or other vegetation, as well as the application of herbicide or other forms of vegetation management when deemed necessary by the Cooperative for safety, reliability, efficiency, or similar reasons pertaining to the electric energy or telecommunications systems.

EXPLANATION FOR SEC PROPOSED BYLAW AMENDMENTS

The Shelby Electric Cooperative Board of Directors proposes the addition of a new sub- paragraph (d) to both Sections 2 and 3 for the purpose of aligning the bylaws with the terms of the membership application which includes a grant of easement to the Cooperative by the member, and the terms of that easement. The Board also proposes a change to the introductory paragraph of each Section which would replace the word "he" with the neutral term "they." The same language is proposed for both Sections 2 and 3.



EIGHTY-FOURTH ANNUAL MEETING OF SHELBY ELECTRIC COOPERATIVE

The Eighty-fourth Annual Meeting of the members of the Shelby Electric Cooperative was called to order by Chairman of the Board Robert Holthaus in the 4-H Auditorium at the Shelby County Fairgrounds, Shelbyville, Illinois, at 1:00 p.m., Friday, June 9, 2023. Following the playing of the National Anthem, Dustin Theiss, Coordinator for Broadband and Member Services for Shelby Electric, delivered the invocation.

Secretary David Keown then read to the members the Legal Call of the Eighty-fourth Annual Meeting of members which was as follows:

LEGAL CALL

DAVID KEOWN, Secretary of Shelby Electric Cooperative, hereby reports that, at my direction, on the 19th day of May, 2023, a notice of the annual meeting of members of the Cooperative to be held on June 9, 2023 was deposited by or on behalf of the Cooperative in the United States Mail, with postage prepaid, addressed to each active Class A member of the Cooperative at the address of said active Class A member as it appears in the records of the Cooperative.

After the reading of the Legal Call, Chairman Holthaus introduced the Board of Directors. Chairman Holthaus

also recognized Craig Sondgeroth, President/CEO of the Association of Illinois Electric Cooperatives, as well as several employees of Prairie Power Inc., including President/CEO Eric Hobbie.

Chairman Holthaus next introduced the winners of Shelby Electric Cooperative scholarships. Each year, Shelby Electric Cooperative awards three \$1,000 scholarships to high school seniors. Applicants must be children of current members receiving electric service and must be furthering their education at a four- or two-year college or university, including vocational and technical schools, located in the United States. The recipients are selected based on academics, community involvement, character, and financial need. The following students were recognized in 2023 as \$1,000 scholarship recipients:

Greg Mackling, Chair of the Committee on Credentials delivered the report of the Committee, said report being as follows:

REPORT OF THE COMMITTEE ON CREDENTIALS OF THE 84th ANNUAL MEETING OF THE SHELBY ELECTRIC COOPERATIVE, JUNE 9, 2023

We, the undersigned members of the Committee on Credentials appointed to serve for the 84th Annual Meeting of the Shelby Electric Cooperative, held June 9, 2023 at 1:00 p.m., do hereby certify as follows:

That we, and each of us, have examined the credentials of the active Class A members of the Shelby Electric Cooperative present for the 84th Annual Meeting, and report as follows:

That the total number of active Class A members present in person are 563;

That the total number of active Class A members presenting duly executed proxies is zero;

Making a total of 563 active Class A members present in person or by proxy.

Chairman Holthaus declared a quorum to be present and the meeting open for the transaction of business.

Chairman Holthaus announced that written copies of the minutes of the Eighty-third Annual meeting of the members, held on June 10, 2022, had been included in the notice of meeting and had also been made available to the members prior to the meeting and asked if there was a motion to approve the minutes as published. On motion of member Marion L. McVey, seconded by member Richard Simms, the minutes as published were approved by vote of the membership.

Chairman Holthaus then delivered his report as Chairman of the Board of Directors of the Cooperative. Chairman Holthaus recognized Shelby Electric Cooperative staff present and extended his and the Board's sincere appreciation for their hard work during the year. He commended everyone for their dedication to safety and for maintaining such a safe workplace. He also expressed his appreciation for the members of the Board, who dedicate a significant amount of time and effort into guiding the Cooperative in service to the members. Chairman Holthaus recognized the fact that it has been a busy and successful year for the cooperative, with a lot of work focused on improvements to the electric distribution system and on broadband deployment.

Chairman Holthaus then acknowledged the retirement of two members of the Cooperative's Board of Directors; thanking Larry Durbin and Brian Halbrook for their years of service.

Chairman Holthaus then introduced the Cooperative Treasurer, Greg Mackling, who reviewed the Annual Report as published in the annual meeting notice. He reported that the Cooperative had annual revenues in 2022 of approximately \$35 million from the sale of electric service and that approximately \$22 million was paid by the Cooperative to purchase electricity. He reported that 2022 total margins were \$3,618,664. The Cooperative's total assets are approximately \$84 million, that the Cooperative has approximately \$32 million in liabilities, making the net value of the Cooperative approximately \$52 million.

Treasurer Mackling reported that the Cooperative continues to invest nearly two times as much in providing reliable service to each member when compared to the investment of members in the Cooperative.

Treasurer Mackling reported that Shelby Energy Company, the Cooperative's propane subsidiary had over 3,100 customers and in 2022 had total sales of over \$3.6 million. As a wholly owned subsidiary of Shelby Electric, Shelby Energy continues to remain profitable.

PWR-net is a division of Shelby Electric that provides broadband internet service. Treasurer Mackling reported the PWR-net division continues to remain profitable with over 1,400 customers and net income in 2022 of just over \$275,000.

Lastly, Treasurer Mackling informed the members that the annual audit was completed by a Certified Public Accounting firm and that copies of the Cooperative audit were available for those members that were interested in reviewing it.

After receiving the Report of the Cooperative Treasurer, on motion of member Charles Bishop, seconded by member Maurice Isaacs, said Treasurer's Report was received and unanimously approved by vote of the membership.

At the request of Chairman of the Board Robert Holthaus, the Cooperative's attorney, Amy Jackson, took charge of the meeting for consideration of the proposed amendment to the bylaws and on the procedure for the election of directors.

Attorney Jackson reported that the proposed amendment to the bylaws was published in the Annual Meeting notice, along with an explanation of the rationale behind the proposed amendment. She reported that the proposed change is the addition of a Dispute Resolution process in Article I, Section 10. The proposed bylaw amendment would provide a cooperative means for resolving disputes that arise between the Cooperative and one or more members. The dispute resolution proposal is for a three step process that includes 1) informal negotiations; 2) non-binding mediation; and 3) binding arbitration. Both the Cooperative and the membership would be required to observe this process in the event of a dispute.

She reported that the proposed bylaw amendment had been placed on the written ballot that was distributed to each member upon registration at the Annual Meeting.

Attorney Jackson then reported on the election of directors. She reported that nominating petitions with the requisite number of signatures by Class A members of the Cooperative and properly completed Statements of Qualification as required by the Cooperative's bylaws had been received from the following persons not less than 60 days prior to the date of the annual meeting:

She reported that both directors will be elected to serve a full three-year term.

She reported also that the names of all persons who had delivered the duly signed petition and Statement of Qualifications to the Cooperative legal counsel had been placed on the written ballot which was distributed to each member upon registration at the Annual Meeting.

Attorney Jackson then asked the members who had not yet cast their ballot to do so.

President and CEO Josh Shallenberger addressed the meeting and noted his gratitude for such good attendance. The electric distribution system covers 2,214 miles and provides service to over 10,000 meters. Safety and reliability of the system continue to be of the utmost importance to the Cooperative. With this in mind, the past year has seen much activity in the way of system improvements to enhance reliability and prepare for future use of infrastructure. Maintaining and improving the system is an ongoing effort and requires significant expenditure of capital in order to maintain quality infrastructure.

CEO Shallenberger told the gathered members that efforts are continually being made to enhance and maintain system reliability. These efforts include compliance with a construction work plan and adherence to a necessary vegetation management program. Significant issues encountered in the past year included delays due to supply chain issues as well as inflationary increases in the price of goods and materials.

CEO Shallenberger reported that after more than 2,000 days with no lost time incidents, the Cooperative did experience an employee injury resulting in lost time. Nevertheless, CEO Shallenberger is very proud of the efforts of Cooperative employees to maintain a safe workplace.

CEO Shallenberger also commented on the increasing development of solar and other renewable energy sources. As of the meeting date, the Cooperative had 163 systems approved for interconnection with the electric distribution system. Attempts are being made, both locally and statewide, to streamline the process for interconnection of renewable energy sources.



CEO Shallenberger addressed the Cooperative's efforts to build a reliable broadband/fiber optic network to provide high speed internet for those in Shelby Electric's service territory. The fiber optic network will be a generational asset for the membership, and it will be a key component for reliable electric systems of the future. According to CEO Shallenberger, the Cooperative is attempting to utilize federal and state funding in order to build the network and bring good, reliable, high speed internet service to the rural areas. This service will be provided under the name "Shelby Fiber," and this is an exciting opportunity for the Cooperative and the membership.

At this point in the meeting, President and CEO Shallenberger introduced Eric Hobbie, President and CEO of Prairie Power, Inc. (PPI), the generation and transmission cooperative of which Shelby Electric Cooperative is a member, and from whom electric energy is purchased.

CEO Shallenberger engaged in a dialogue regarding relevant issues and challenges facing electric cooperatives. Eric Hobbie explained how PPI has intentionally diversified its power supply, including owning a portion of the power supply, as a way to create stability for PPI and its member cooperatives. According to Eric Hobbie, this allows PPI to hedge against shifts in the market that would otherwise impact not only the availability of power, but the price of power.

Eric Hobbie and CEO Shallenberger also discussed the troubling news regarding the risks associated with retiring generation sources faster than new sources are being built. This is a nationwide issue but is especially pertinent in Illinois in light of the recent legislation requiring phase out and closure of fossil fuel generation, including the Prairie State Energy Campus of which PPI is a part owner.

In concluding his remarks, CEO Shallenberger acknowledged and thanked Cooperative staff for the valuable impact they have on the communities served; including the annual Touchstone Energy Balloon Fest, the CEO Programs in Shelby and Christian County, the CoBank Sharing Success program, as well as numerous other opportunities for community involvement and monetary support.

At the conclusion of CEO Shallenberger's comments, Chairman Holthaus asked if there was any other business to be addressed. Hearing none, he then called upon Jessica Fox, Chair of the Inspectors of Elections to read the Certificate of Inspectors of Election, as follows:




